## Lift Station No. 4 – Electrical Upgrades:

Construction of upgrades for Sanitary Sewer Lift Station #4, the scope of which includes the demolition and replacement of the existing Pump Starter Panel, Manual Transfer Switch, Flow Meter, Conduits, Conductors, Meter Base, PSE conductors from the existing transformer, Bypass Pumping, and other work necessary to complete the work as specified and shown in the Contract Documents.

## Lift Station No. 12 – Wet Well Rehabilitation:

Construction of upgrades for Sanitary Sewer Lift Station #12, the scope of which includes the cleaning, prepping, and complete coating and lining of the entirety of all four interior walls of the existing wet well.
