Media Release: Officer Involved Shooting at 205 S. 7th St Renton

The Valley Independent Investigative team (VIIT) is serving as the independent investigative team for this OIS. VIIT is a multi-agency team made up of investigators from seven south King County Police Departments (Auburn, Des Moines, Federal Way, Kent, Renton, Port of Seattle, and Tukwila). As this incident involved the Renton Police Department, all RPD staff have been excluded from this VIIT investigation.

Investigators from the Valley Independent Investigative Team are continuing their investigation into the events that occurred on 13 April. The 24-year-old male who was involved in the shooting remains at Harborview Medical Center in the custody of King County Adult Detention.

There have been no significant updates to the investigation this week.

Media Release: Officer Involved Shooting at 205 S. 7th St Renton

The Valley Independent Investigative team (VIIT) is serving as the independent investigative team for this OIS. VIIT is a multi-agency team made up of investigators from seven south King County Police Departments (Auburn, Des Moines, Federal Way, Kent, Renton, Port of Seattle, and Tukwila). As this incident involved the Renton Police Department, all RPD staff have been excluded from this VIIT investigation.

Investigators from the Valley Independent Investigative Team are continuing their investigation into the actions of the personnel involved in the 13 April 2022 officer involved shooting. The involved officers were not injured during the incident, however the 24 year old involved subject sustained life threatening injuries. Immediately following the shooting, officers on-scene provided first aid until Renton Fire Authority and King County Medic One personnel arrived and took over life saving measure.

The involved 24 year old subject was transported to Harborview Medical Center for emergency surgery and follow on medical care. Following surgery the subject was transferred to the Intensive Care Unit where he continues his recovery.

Initial Release: Officer Involved Shooting at 205 S. 7th St Renton

The Valley Independent Investigative team (VIIT) is serving as the independent investigative team for this OIS. VIIT is a multi-agency team made up of investigators from seven south King County Police Departments (Auburn, Des Moines, Federal Way, Kent, Renton, Port of Seattle, and Tukwila). As this incident involved the Renton Police Department, all RPD staff have been excluded from this VIIT investigation.

On 13 April 2022, at approximately 1128HRS personnel from the Renton Police Dept and the King County Sheriff's Office responded to the Metro Park and Ride located at 205 S. 7th St for a report of an adult male subject at the location holding a gun. Shortly after arriving on-scene responding units contacted a subject near the bus shelters. During the contact the subject refused to comply with verbal commands given by Officers and produced what appeared to be a firearm from a pocket. Officers on-scene fired their duty weapons striking the subject. Officers on-scene rendered first aid until Fire Department and King County Medic One personnel arrived on-scene. The 24-year-old male was transported to Harborview Medical Center for emergency care.

Detectives from the Valley Independent Investigative Team were notified of the incident and responded to the scene and began their investigation. Access to the Park and Ride and traffic in the area were impacted by partial road closures and restricted access to the Park and Ride until approximately 1945HRS.
